

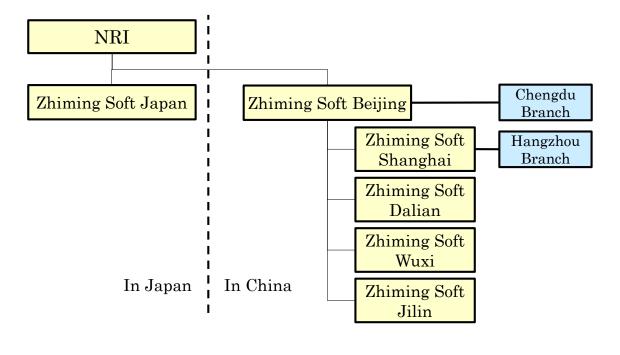

Nomura Research Institute to establish Zhiming Software with acquisition of SinoCom Software's IT development business

TOKYO, October 29, 2015 - Nomura Research Institute, Ltd. (NRI), a leading provider of consulting services and system solutions, announced that it successfully acquired certain segments of IT business of SinoCom Software Group Limited, which had been one of NRI's major offshore partners in China. The acquisition was completed on October 28, 2015, based on the agreement placed on June 17, 2015.

With acquired business segments, NRI founded Zhiming Software on the same day. Zhiming Software consists of 1,300 employees and six business entities both in China and Japan. As a result of this acquisition, the number of NRI group's employees has now exceeded 10,000.
